

# Fleet Vehicle Rates

(Effective 7/1/2009)

## Minnesota State University, Mankato state vehicles:

Vehicle Type	Daily	or Half Day*
Sedan	\$42.00	\$26.00
Minivan	\$68.00	\$41.00
12 Passenger	\$90.00	\$54.00

Since July 1, 2006 a \$100/trip "surcharge" per vehicle/per trip for out-of-state travel with a state vehicle(s) will be charged.

State Agencies may not rent 15 passenger vehicles under any circumstances.

## Rate Comparison:

Vehicle Type	MSU	Enterprise Rent-A-Car
<b>Mileage</b>	<b>Unlimited Mileage</b>	<b>Unlimited Mileage**</b>
<b>Sedan</b>	<b>\$42/day \$26/half day *</b>	<b>\$39.50 +16.2% tax + fuel costs</b>
<b>Example: 1 Day charge @ 150 miles</b>	<b>\$42</b>	<b>\$39.50 + \$6.40 = \$45.90 (plus fuel costs)</b>
<b>Mini Van</b>	<b>\$68/day \$41/half day *</b>	<b>\$60.50 +16.2% tax + fuel costs</b>
<b>Example: 1 Day charge @ 150 miles</b>	<b>\$68</b>	<b>\$60.50 + \$9.80 = \$70.30 (plus fuel costs)</b>
<b>Large 12 Passenger Van</b>	<b>\$90/day \$47/half day *</b>	<b>\$137.50 \$137.50 + 16.2% tax + fuel costs</b>
<b>Example: 1 Day charge @ 150 miles</b>	<b>\$90</b>	<b>\$137.50 + \$22.28 = \$159.78 (plus fuel costs)</b>

\* Half Day rates are utilized if the vehicle is returned prior to 1:30PM each day during academic year. During summer months, 4 hour increments will be utilized for Half Day rates. MSU pays for fuel (already included in the rate) with assigned fuel cards.

\*\*Enterprise Rates include unlimited mileage on daily and weekly rates on all vehicles. Customer pays for fuel. Additional costs could apply.

If you do not use Minnesota State University, Mankato vehicles two contracts were awarded to Enterprise Leasing Company through Materials Management Division, State of Minnesota Administration Department. **Contract Release: V-33(5) Vehicle Rental "Local Service"** – Short and long term rentals: Due to the High Liability exposure for the service on the contract, State agencies are required to use the contract unless an exception is granted by the Acquisition Management Specialist (AMS) with the State of Minnesota. Renters must be 18 years of age or older to use the contract.

**Contract Release: V-38(5) Vehicle Rental – National Service for Rentals that Initiative outside of the State of Minnesota – Short Term Rentals.** Renters must be 21 years of age to use the contract.
