## STUDY ABROAD TOURS

We believe study abroad tours provide students with immeasurable experiences and knowledge, as well as extend their network across the globe of new friends and potential employers. So far, trips taken include tours to Great Britain (England, Scotland and Northern Ireland), Iceland, Ireland, Spain, Italy, Switzerland, France, the Netherlands, Germany, the Czech Republic, and Austria.

In addition, international travel often brings to a person a greater degree of confidence in one’s self, an appreciation or understanding of how to function in a different culture, and a heightened level of adaptability that was not realized prior to international travel. Most importantly, we want students to feel prepared for anything as well as have an exceptionally fun yet educational time!
