The <u>Minnesota Department of</u> <u>Education Notice of Student</u> <u>Registration Form</u> is an essential part of the enrollment process for PSEO students.

This guide will explain what the Minnesota Department Notice of Student Registration Form is and why it is important for PSEO students to ensure they turn in prior to the start of the semester.

What is the Minnesota Department of Education Notice of Student Registration Form?

- The <u>Minnesota Department of</u> <u>Education Notice of Student Registration</u> <u>Form</u> serves as **documented notification** that a student plans to take PSEO classes with Minnesota State University, Mankato.
- The PSEO Department will require this form for enrollment each semester.
- High schools will require this form to notify their district of students planning to take PSEO classes.
- The Minnesota Department of Education will use this form to waive tuition and fees for a student.
