An <u>undergraduate</u> student may apply for academic forgiveness when <u>one</u> of the following conditions is met: Not been enrolled in any Minnesota State Mankato courses for a minimum of 3 consecutive academic years prior to the "point of academic forgiveness."

Chose an unsuitable major which led to academic performance less than academic ability.

After one of the above requirements is met, the student then needs to demonstrate adequate academic ability by completing the following:

Minimum of 12 semester credits with a minimum GPA of 2.0, and a grade of "C" or higher in each course.

If Academic Forgiveness is approved, the student may request to exclude all courses with the grade of F, or all courses with the grades of D and F, prior to the point of academic forgiveness.

Request that all courses prior to academic forgiveness with the grade of F be excluded from GPA and attempted credits.

Request that all courses prior to academic forgiveness with the grade of F and D be excluded from GPA, attempted credits and earned ("D") credits. Note: Does not apply for courses that were used to satisfy previous academic requirements or credentials (e.g., a degree, certificate, goal area within General Education, Veterans Benefits, Academic Athletic Eligibility etc...)

# ACADEMIC FORGIVENESS FOR UNDERGRADUATE STUDENTS' ADVISEE GUIDE

You can apply for Academic Forgiveness for one of two reasons:

- 1. You have not enrolled in any Minnesota State Mankato courses for a minimum of 3 consecutive academic years period to the "point of forgiveness."
- 2. You selected an unsuitable major which led to an academic performance that is below your academic ability.

Following the "point of forgiveness," you must achieve a 2.00 GPA, and grades of "C" or higher in each class for the first 12 credits.

Important advising notes about Academic Forgiveness:

- It can only happen <u>one</u>-time in your academic career.
- It does <u>not</u> impact your credit completion rate therefore, you should talk with the Campus Hub to learn about how this impacts financial aid warning or suspension status.
- It <u>cannot</u> apply to courses that were used to satisfy previous academic requirements or credentials (e.g., a degree or certificate, goal area within General Education, Veteran's Benefits, Academic Athletic Eligibility, etc...).
- You can choose to impact all of your Ds, or <u>all</u> of your Ds and Fs. It does <u>not</u> impact Ws.
- If you are applying because of an unsuitable major, you need to demonstrate adequate academic ability by completing a minimum of 12 semester credits with a minimum GPA of 2.00 and a grade of "C" or higher in each class.

o This applies to the first 12 semester credits after "point of forgiveness."

o Semester GPA will be used to determine whether you've met this requirement (if you have taken more than 12 credits during a semester, <u>all</u> of those credits will be used; if you have been part-time, multiple semester GPAs will be used until you have met or exceeded 12 credits).

o If you are applying because of an unsuitable major, what new major have you selected? What helps you feel confident that this major is more suitable for you?

• It is considered a misuse of this policy to change your major away from a particular program to go through Academic Forgiveness and then change your major back to the original major.
